



## Stallion Service Contract

*This service is engaged subject to the following:*

1. Stallion Fee \$1000.
2. Board \$10 for dry, \$15 for wet per day/ Shipped Semen \$ 250 per shipment.
3. Deposit in amount of \_\_\_\_\_ is payable with this contract and will be applied against the above stallion fee.
4. The mare shall be in a healthy and sound breeding condition and mare owner agrees to said mare being treated by Licensed Veterinarian for anything that would ensure her well-being, and also agrees to pregnancy examination said mare, all at his expense.
5. Mare shall be halter broken.
6. Stallion owner or manager of stallion will not be liable for accident, sickness, or death to said mare and/or her foal but will exercise his best judgement in the care of said mare and /or her foal. It is also agreed that mare owner will not be liable for any disease or injury to said stallion.
7. It is further agreed that should the above stallion die or become unfit for service, or should the above mare die or become unfit for breed, then this contract shall become null and void and deposit will be returned.
8. Stallion owner guarantees a live foal from this mating. A live foal shall be defined as a foal that stands and nurses without assistance. Should foal not stand and nurse, mare owner agrees to notify stallion owner within seven (7) days of foaling date and furnish statement from Licensed Veterinarian, and mare owner will be entitled to return privilege with this same mare, unless otherwise mutually agreed.
9. When stallion owner is convinced that the mare is in foal, mare owner will be notified that the mare is ready to be picked up, at which time all unpaid bills, including board, veterinarian bills, breeding fees, etc., are due and payable.
10. Stallion Service Certificate will be issued only after mare owner has notified stallion owner that said mare has produced live foal and all bills on mare have been paid.
11. Stallion owner or manager of stallion agrees to diligently try to settle (impregnate) said mare up to and including July 1<sup>st</sup>, (unless otherwise arranged at the time of signing this contract). Mare owner agrees to give stallion owner or manager ample opportunity to settle her (having bred

her through at least two (2) heat periods or being certified in foal by a veterinarian). However, if for any reason she does not settle, mare owner will hold stallion owner or manager harmless.
